In international commercial arbitration, he appears in ad hoc and institutional arbitrations seated in and outside India governed by the (Indian) Arbitration and Conciliation Act, 1996 and all the main rules, including those of Singapore International Arbitration Centre, International Chamber of Commerce, London Court of International Arbitration, Hong Kong International Arbitration Centre and Dubai International Arbitration Centre.

In disputes arising out of construction contracts, Rajdeep also appears before Dispute Adjudication Board and Dispute Avoidance/ Adjudication Board.

Rajdeep's understanding of technical aspects of disputes coupled with his industry knowledge and effective oral and written advocacy equips him to present clients' positions to courts and tribunals persuasively.
